



Super Summer Fun

Welcome to the Golay Community Center Super Summer Fun program for elementary aged children. We are excited for your child to join us this year. Please complete the attached packet (all forms must be filled out and signed by the legal guardian.)

There is a \$15 non-refundable registration fee per child that must be paid at enrollment. We ask that all children attending the Super Summer Fun program bring swim wear daily (bathing suit, towel, goggles, etc.). We have teamed up with the Lincoln High School Cafeteria, a morning snack and lunch will be provided for children attending the SSF program (**due to cafeteria shut down July 5-8 children will need to pack their lunch on these days**). They are more than welcome to pack their lunches if they wish.

We have partnered up with Purdue Extension and Cope Environmental Center to bring in some educational and fun activities throughout the summer. Purdue Extension will be here every Monday 8:30-10:00am, and Cope Environmental Center will be here every Tuesday 10:00-11:30am.

All checking in/out and payments will be done at the Golay Center front desk. Payments will be broken down in two categories Full Time (4-5 days a week) \$80, or Part Time (1-3 days a week) \$60 per child. There will be a \$10 discount for each additional child. Payments will be expected by pick up on Friday, or by drop off on Monday and can be made at the Golay Center's front desk. Children with an outstanding balance will not be allowed to be dropped off until balance is paid.

Once all forms are complete and fees are paid, your child is ready to start! Super Summer Fun runs Tuesday, May 31st-Friday, August 5, 2022 (no camp Monday, July 4). Hours of operation are 7:00am-6:00pm.

Payment/Discipline Form

FEES

Non-refundable registration fee \$15 per child

All balances MUST be paid on Friday at pick up or on Monday at drop off; failure to do so will result in suspended services and the child will not be allowed to stay in the program. *There will be no exceptions.* Further, if there is an unpaid balance at the conclusion of Super Summer Fun, that balance must be paid to be able to participate in any other Golay Center activities, including memberships and day passes.

PERSONAL ARTICLES

Students are discouraged from bringing Pokemon cards, expensive toys, sporting equipment, large sums of money, and electronics (phone, tablets, gaming devices, etc.) to the program. The program cannot be responsible for any items that are lost, stolen, or broken.

ARRIVAL AND PICK-UP

1. The only people allowed to pick-up a child are those indicated on the child's record.
2. Each child must be signed in and out by an authorized adult at the Golay Center's front desk.
3. Children will not be allowed to sign themselves in or out. **A parent must accompany the child into the building.**

EXPECTED BEHAVIOR

1. All students are expected to always show respect for all staff members and fellow children.
2. No fighting, name calling, pushing, shoving, stealing, or unacceptable behavior will be tolerated.
3. All children are expected to clean their areas after snack and play time.
4. All children are to respect the property of the Golay Community Center and the Super Summer Fun program.
5. Safety and fairness are expected.
6. It is a privilege to attend the Super Summer Fun program. While it is the goal of the Super Summer Fun program to allow a student the opportunity to eliminate inappropriate behavior, the severity and/or frequency of a major behavior incident will determine the consequence.

STUDENT DISCIPLINE

Discipline is based on the worth and dignity of each individual. The program's role is one of strong leadership and helping students grow toward self-discipline and self-direction. Personnel will administer discipline within the program as would be exercised by a kind, firm, caring, judicious parent in the home. Continued unacceptable behavior by the student may result in suspension or removal of that student from the program.

- _____ I understand that SSF fees are to be paid on Friday and payments are due no later than the following Monday at drop off or your child may not attend SSF.
- _____ I understand that SSF fees are based on weekly services and will not be prorated.
- _____ I agree that I will pick up my child by 6:00pm or earlier, and I understand that it is my responsibility to provide alternative arrangements for picking up my child if I am unavailable.
- _____ I understand that my child is to be signed in and out every day by an adult and that I am not to leave my child until a staff member receives my child.
- _____ I understand that my child will not be allowed to leave the program with an unauthorized person. Any person authorized to pick up my child must be listed on this form.
- _____ I understand that the Golay Community Center is mandated, by state law, to report any cases of child abuse or neglect to the appropriate authorities for investigation.
- _____ I understand that in the event of continued late payments, late pickup of my child, or for any other good cause, the Golay Community Center reserves the right to remove my child from the SSF program.
- _____ I understand that if my child fails to abide by the rules and regulations of the Golay Community Center he or she is subject to removal from the premises and/or removal from participation in Golay Community Center programs and activities without a refund of dues, fees, or other amounts paid to the Golay Community Center.
